## § A8-A801. Sewers.

- 8-1. Pertaining to the sewering of Washington Street, from Keller Street to the sink north of the Cumberland Valley Railroad, and providing for the payment of the same. (Ord. 203, 7/25/1910)
- 8-2. Pertaining to sewering the north side of West Allen Street, from Frederick Street east 522 feet to intersect with the brick sewer on Railroad Avenue and providing for the payment of same. (Ord. 231, 7/17/1912)
- 8-3. Authorizing the proper officers to engage the services of the engineering firm of Gannett, Fleming, Corddry and Carpenter, Inc., of the City of Harrisburg, Dauphin County, Pennsylvania, in connection with the proposed installation of a sewerage system, including a disposal plant, in the Borough of Mechanicsburg, Cumberland County, Pennsylvania; and also authorizing the proper officers of the said Borough of Mechanicsburg to enter into such contract or contracts with the said engineering firm of Gannett, Fleming, Corddry, and Carpenter, Inc., which may be necessary. (Ord. 435, 2/20/1946)
- 8-4. Authorizing the execution of an agreement of sewer lease by the Borough, as lessor, of the sanitary sewage system and sewage treatment plant to be constructed by said Authority, and the payment of rentals by said Borough under the terms of said lease; approving the form of said lease; providing for the execution of a supplemental sewer lease under certain conditions; providing for the execution of all papers and instruments necessary and proper for such purposes; ratifying and confirming the terms and provisions of an ordinance of the Borough enacted May 23, 1949, fixing the sewer rates for said Borough, etc.; and providing for the repeal of existing ordinance inconsistent herewith. (Ord. 474, 6/15/1949) (This agreement was with the Municipal Authority of the Borough of Mechanicsburg.)
- 8-5. Authorizing and directing the proper officials to execute, on behalf of the said Borough, a certain agreement between the Pennsylvania Railroad Company, a party of the first part, and the Borough of Mechanicsburg and the Municipal Authority of the Borough of Mechanicsburg, parties of the second part. (Ord. 479, 9/17/1949) (This ordinance authorized an agreement for an outfall sewer under the Cumberland Valley Branch tracks at the following points; Arch Street at Mile Post No. 8, Market Street at Mile Post eight plus 573 feet and Mile Post eight plus 4,427 feet.)
- 8-6. Authorizing and directing the proper officers to execute, in behalf of the said Borough, a certain agreement between the Pennsylvania Railroad Company, party of the first part, and the Borough of Mechanicsburg and the Municipal Authority of the Borough of Mechanicsburg, parties of the second part. (Ord. 480, 9/17/1949) (This ordinance authorized an agreement for an outfall sewer under the Dillsburg Branch track at Mile Post No. 9 plus 1,342 feet.)
- 8-7. Authorizing the execution of an agreement of supplemental sewer lease by the Borough, as lessee, with the Municipal Authority of the Borough of Mechanicsburg, Cumberland County, Pennsylvania, as lessor, of the sanitary sewer system and

sewage treatment plant as constructed by said Authority, and the payment of rentals by said Borough under the terms of said supplemental sewer lease; approving the form of said lease; providing for the execution of all papers and instruments necessary and proper for such purposes; ratifying and confirming the terms and provisions of an ordinance of the Borough enacted May 23, 1949, fixing the sewer rates for said Borough, etc., and providing for the repeal of existing ordinances inconsistent herewith. (Ord. 494, 7/24/1951)

8-8. Authorizing and approving a second supplemental agreement of lease, dated as of June 1, 1967, between the Municipal Authority of the Borough of Mechanicsburg, as lessor, and this Borough, as lessee, to an agreement of lease, dated as of June 1, 1949, between said Authority, as lessor, and this Borough, as lessee, as previously supplemented, pursuant to which the term of said agreement of lease will be extended to end May 31, 2001, and said Authority will agree to construct certain enlargements, improvements and additions to its sewer system and this Borough will agree to pay certain additional net lease rentals; consenting to assignment of said second supplemental agreement of lease to Dauphin Deposit Trust Company, trustee under a trust indenture of said Authority, dated as of June 1, 1949, as supplemented by first and second supplemental trust indentures thereof; directing execution, acknowledgement and delivery of said second supplemental agreement of lease; and directing other action. (Ord. 740, 5/23/1967)

8-9. Authorizing and approving an agreement, dated as of March 14, 1977, between the Municipal Authority of the Borough of Mechanicsburg and the Borough, on the one hand, and Silver Spring Township, on the other hand, whereunder, inter alia, the Municipal Authority of the Borough of Mechanicsburg and the Borough of Mechanicsburg covenant to construct and acquire additions and improvements to the sewage treatment and disposal facilities now owned by the Municipal Authority of the Borough of Mechanicsburg and leased to the Borough of Mechanicsburg, and to receive, treat and dispose of certain sanitary sewage and wastes from the sewage collection system to be constructed by Silver Spring Township; setting forth terms with respect to sharing the costs of such construction and the operation of the jointly used facilities; authorizing and directing execution and delivery of said agreement, by proper officers of this Borough; and authorizing and directing other necessary and proper action. (Ord. 8743/15/1977)

8-10. Authorizing action with respect to acquiring the sewer system presently owned by the Municipal Authority of the Borough of Mechanicsburg; assuming obligations of said Authority with respect to the sewer system, including obligations under a trust indenture, dated as of June 1, 1949, as amended and supplemented; approving an agreement, dated as of February 1, 1984, but effective as provided therein, which sets forth the manner in which the foregoing shall be implemented, and which terminates an agreement of lease, dated as of June 1, 1949, as amended and supplemented; approving an irrevocable escrow agreement, dated as of February 1, 1984, but effective as provided therein, by and among the aforesaid authority, this Borough and Dauphin Deposit Bank and Trust Company; authorizing and directing specified officers of this Borough to take certain actions, including execution and delivery of the aforesaid agreements; providing when this ordinance shall be effective; providing for severability of provisions; and repealing all ordinances or parts of ordinances insofar as the same shall be inconsistent herewith. (Ord. 930, 2/20/1984)

8-11. Adopting a Sewage Facilities Planning Module for the Maplewood/Elmwood Sewer Project for a sewer extension and submitting same to the Department of Environmental Protection for its approval as a revision to the Official Sewage Facilities Plan. (Res. 09-2006, 7/6/2006)
